Don't forget water, snacks and sunscreen. This field trip is open only to members of the Northern Virginia Mineral Club. From the Editor:

Jeffrey Stewart was contacted in regards to having children attend this class. Can your child receive certification? This is possible if the child is in high school and shows good participation and understanding of the material presented. Ultimately it is up to the instructor to decide whether to issue certification or not.

There is no age restriction for receiving a GMMC, but a person needs to be 18 years of age and have a GMMC to work in a mine. So, using a GMMC strictly for access to a mine is a different matter, and has no legal age restriction.

If you would like to bring your child to this certification class, this is OK as long as the child is attentive and not disruptive.

The Rockville Quarry and the \$5 gratuity

An Historical Perspective

Thanks to the owners of the Rockville Crushed Stone Quarry, aka the Hunting Hill Quarry, and to the former superintendent John Croney and present quarry director Jeffrey Greene, several of our local mineral groups have had limited collecting opportunities at the quarry over the past several years. However, there were years previously when this access was not permitted. Let's begin back in the mid 1980's about the time the author joined the NVMC.

During the 1985-1988 time period, admission to the quarry was relatively easy to come by for the local mineral clubs. Trips were on Sundays, usually limited to one club at a time, collectors could stay as late as 4pm, and no gratuity was collected. Cars would be lined up in single file outside the quarry gate. At 9:30am the gate would open, and everyone drove down into the pit, scattering over various level and rock piles. Although not every trip was a success, there were some dates that are memorable, including the following:

Aug 25, 1985: discovery of blue meguinnessite crystals

Sept. 29, 1985: discovery of what turned out to be orange desutelsite crystals

Oct. 19 & Nov. 9, 1986: good collecting trips for grossular garnets

Jul. 17, 1988: hottest field trip ~101-81 weather bureau readings

Feb. 7, 1988: coldest field trip 29-11 weather bureau readings (3 club member showed for this chilly trip)

Dec. 11, 1988: a NVMC trip which became the last field trip for years to come. Quarry management decided to close the Rockville Quarry to collectors.

There developed one exception, the micromounter's club (MNCA), in conjunction with their annual conference, got special permission to have up to 25 conference attendees (with Eastern Federation insurance) collect at the quarry for about 3 years—1989-1991. The trip of April 7, 1991 was especially noteworthy in that the rubble pile contained specimens with grossular garnets. However, this trip was the last one; thereafter, no club could get permission to collect at the Rockville Quarry.

Access to the Hunting Hill Quarry has not always been so easy....

We are access to this site at all.

Fast forward to summer, 1995. the author got a surprising phone call from Paul Smith. A field trip to Rockville Quarry had been arranged for Sunday afternoon, Aug 6, 1995. The trip was limited to 15 persons, by invitation only, from various local clubs. There were heavy rains before the trip refortunate to get sulting in lakes in the quarry. The afternoon became sunny but very humid; attendees were limited to remain within sight, on one quarry level. There was sufficient rubble for us to

> examine, and it felt good to be back in the quarry. In appreciation, Paul Smith began the practice of collecting \$5 from each participant, and giving the money to the quarry manager, without whose presence the trip would not have occurred.

There were no more field trips to the Rockville Quarry in 1995. Also there were none in 1996. Jack Nelson, of the Montgomery County Mineral Club, decided he would look into this, and somehow he got permission for his club to collect at the quarry on May 18, 1997, a Sunday afternoon. This trip was the occasion of finding a new mineral for the Rockville Quarry, namely Ilmenite. The practice of donating \$5 per attendee, to give to the guarry manager for his expenses and his time, was continued for this trip, and for later trips, and even until now.

The first NVMC field trip to Rockville Quarry since Dec 11, 1988 was on Oct 25, 1998 - a time gap of almost 10 years!

Tidbits

DID YOU KNOW?

You might notice that some websites (and the electronic version of this newsletter) do NOT show email addresses as hyperlinks or even as text. Instead, they are shown as pictures! This is to help control unwanted email because of software that trolls the internet in search of nothing but email addresses to send spam to! Controlling spam can be challenging, but this is one easy way to help reduce spam.

What is an email group? An email group is an email address that is forwarded to all of the members that have signed onto it. When you send a message to the email address that represents the group, the message is sent to all those that have "subscribed" to the service. This is a free service, and is quite commonly used amongst various clubs and organizations. Such email groups can be a helpful way to get a message to members of the club in a quick manner, or to have casual discussions with other club members in an open forum. For example, let's say that you have a question about


how to clean some minerals you have just obtained on a field trip, but you don't want to wait until the next club meeting to get an answer. You can send a message to the email group and possibly get a quicker answer.

Trotter Diggg 2008 at Sterling Hill Mine April 26th



A picture of the fluorescent "wall" taken with a timed exposure at Sterling Hill in April 2007. This rock wall is about 40' high and is illuminated at sundown using a shortwave UV light. Red is calcite and green is Willemite.

For those of you unfamiliar with the Trotter Diggg (why it has 3 "g"s in diggg is a long story), this is a day of access to the Sterling Hill Mine in Ogdensburg, NJ. This is an historic Zinc Ore mine that is now shut down and in the process of being turned into a protected historical site. This mine is legendary for its immense list of minerals, especially minerals that are fluorescent. Part of the \$20 entry fee (per person) will also grant you access to tours of the upper mine and conveyor belts - grab a piece of ore off the belt from the day the mine was shut down - and also the tour of the lower mine (bring your portable UV lights).

My daughter and I went to this last year, and it was extremely enjoyable. Note, however, that ore removed from the site costs \$1.50 per lb.


